

General Terms and Conditions of Participation in the Prize Draw

1. Organiser

The organiser of the prize draw is ALBACH Maschinenbau AG, Schlierstraße 20, 85088 Menning, with its registered office in Vohburg, entered in the Commercial Register of the Ingolstadt Local Court under HRB 9270.

2. Eligibility

Eligible to enter are natural persons who have reached the age of 18, as well as legal entities, regardless of their legal form.

Each participant may enter only once. Employees of the organiser and their relatives, as well as companies affiliated with participants within the meaning of Section 15 of the German Stock Corporation Act (AktG) and their relatives, executive bodies or legal representatives, are excluded from participation. Participants from countries excluded due to foreign trade sanctions are also excluded, as are participants who are excluded from receiving products from ALBACH Maschinenbau AG for other legal reasons. The organiser may exclude participants from taking part if their participation is manifestly abusive or undertaken for unfair purposes.

3. Prize

The prize to be drawn is the purchase of a construction site for an ALBACH Model Diamant 2000 with machine number 1000.

The final purchase price depends on the specifications requested by the purchaser; the standard price list V26.2 applies. You can obtain details of price list V26.2 from the authorised dealer in your country. Once configured, the machine will be scheduled for production, and delivery will take place in accordance with the regular production cycle.

The allocated production slot is non-transferable and cannot be redeemed for cash.

It is expressly stated that neither the vehicle or the machine itself, nor any discount, reduction or other free service from ALBACH Maschinenbau AG, is being raffled off.

4. Terms and Conditions of Entry

By taking part in the prize draw, the participant agrees that, should they be selected, they are obliged to purchase an ALBACH Diamant 2000 at the applicable price, subject to proof of sufficient creditworthiness and financing options. Participation in the prize draw gives rise to an obligation to purchase the machine, should the participant be drawn, in accordance with the terms set out in price list V26.2.

5. Procedure

Entry is made by completing the online form.

Registered participants will receive a four-digit entry number, which is issued only once and is assigned to the respective participant.

The draw will take place in early October under the supervision of a notary during a barbecue hosted by ALBACH Maschinenbau AG at the company's premises in Menning.

For registered participants who are unable to attend in person, the draw will also be streamed live via a Microsoft Teams link. Attendance at the barbecue is not a prerequisite for taking part in the draw.

An invitation to the barbecue will be sent out separately. The exact date and further details of the event will be announced in the invitation.

Three ticket numbers will be drawn in succession:

1. Building plot with machine number 1000

The first ticket number drawn will win the building plot for the ALBACH Diamant 2000 with machine number 1000.

2. Building plot with machine number 999

The second winning number drawn will be given the opportunity to purchase machine number 999.

3. Building plot with machine number 1010

The third winning ticket number will be given the opportunity to purchase machine number 1010.

Acceptance of the second and third ticket numbers is voluntary and does not entail any obligation to place a binding order for an ALBACH Diamant 2000.

The purchase of machine number 999 or 1010 may therefore be declined.

The obligation to place a binding order for an ALBACH Diamant 2000 – subject to proof of creditworthiness/proof of financing – applies exclusively to machine number 1000 (first prize draw).

6. Registration period for participation in the prize draw

Registration begins on 24 July 2026 at 12:00 CET and ends on 4 September 2026 at 12:00 CET. Entries received after this time will not be considered. The date of receipt of the entry by the organiser shall be decisive.

7. Disclaimer

The prize draw will take place under the supervision of a notary and is final.

The organiser accepts no liability for any damage arising from technical faults, force majeure or interruptions caused by third parties during the conduct of the prize draw. Legal recourse is excluded.

In the event of the purchase of an ALBACH Diamant 2000, the existing statutory warranty rights and legal provisions shall apply. Any further liability on the part of the organiser is excluded – unless otherwise agreed and permitted by law. This does not affect liability for wilful misconduct and gross negligence, or for damage resulting from injury to life, limb or health within the meaning of Section 309(7a) of the German Civil Code (BGB).

8. Notification of winnings

Participants to whom the tickets with the machine numbers 1000, 999/1010 are allocated will be notified in writing by email or post immediately after the draw, regardless of whether they attend the barbecue. The order to purchase the ALBACH Diamant 2000 with machine numbers 1000, 999/1010 must be placed with the organiser within 90 days of notification. If no order is placed within this period, the entitlement to the building plot with machine number 1000, 999/1010 shall lapse.

9. Data protection

The personal data collected in connection with participation (name, address, email address) will be processed by the organiser for the purpose of conducting the prize draw and notifying winners. The legal basis is Article 6(1)(b) of the GDPR (performance of a contractual or pre-contractual obligation). The data will be deleted within 3 months of the end of the prize draw, or at the latest once the winner has been notified, provided that there are no statutory retention obligations to the contrary. An exception applies if you have explicitly consented to the use of your data for advertising purposes in the registration form.

Participants' data will not be used for advertising purposes unless the participant hereby expressly gives their consent. This consent may be withdrawn at any time.

The names of the winners may be published on the organiser's website or social media channels, provided the participant has expressly consented to this. Such consent may be withdrawn at any time.

10. Changes to the Terms and Conditions

The organiser reserves the right to amend the terms and conditions at any time without giving reasons. The amended terms and conditions will be published on www.albach-maschinenbau.de.

11. Severability clause

Should any individual provisions of these terms and conditions be or become invalid, this shall not affect the validity of the remaining provisions. The

invalid provision, a valid provision shall apply which most closely approximates the economic purpose of the invalid provision.

12. Declaration of Consent by the Participant

By taking part in the prize draw, the participant confirms:

“I confirm that I am entering the prize draw only once. I am aware that, in accordance with Section 15 of the German Stock Corporation Act (AktG), only one entry per person, company or affiliated undertaking is permitted, and that employees of the organiser and their relatives are excluded from taking part. This also applies mutatis mutandis to executive bodies and legal representatives. I acknowledge that the prize draw relates to the building plot, but not to the vehicle. I am aware that participation in the prize draw entails an obligation to purchase, finance and take delivery of an ALBACH Diamant 2000 should I be selected in the draw.”
